



2023 LOCAL RULES & TERMS OF THE COMPETITION (REVISED JANUARY 1, 2023)

The *Rules of Golf* as approved by the United States Golf Association and The R&A govern play. These Local Rules and Terms of the Competition are in effect at all Georgia PGA competitions and qualifying rounds. See applicable tournament or qualifying round Notice to Players and Entry Application for modifications or additions to these Local Rules and Terms of the Competition. Complete text of the Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2023. (Rev 1/1/23)

Code of Conduct

Any conduct that is detrimental to the Junior Tour will not be tolerated, including, but not limited to the following:

- Throwing and or breaking clubs
- Using abusive or profane language
- Consumption of alcoholic beverages
- Usage of tobacco products
- Drug use
- Gambling
- Cheating
- Damaging the golf course intentionally
- Abuse of club facilities
- Disrespect to the host facility staff, Junior Tour staff, sponsors, spectators or other players

Any breach of the above guidelines will result in disqualification from the event where the incident occurred; disqualification from the next event in which you entered without refund. Continued violations will result in dismissal from the Junior Tour.

Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty.

(Match Play - Loss of Hole - Stroke Play - Two Strokes)

1. Out of Bounds – Rule 18.2

- a. a. Defined by the line between the course-side points, at ground level, of the white stakes, fence posts and/or white lines.
- b. b. When the inside edge of a road or curb defines out of bounds, a ball that crosses such boundary is out of bounds even though it may lie on another part of the course.

2. Penalty Areas – Rule 17

- a. Penalty Areas are identified by yellow stakes and defined by yellow lines and/or are identified by red stakes and defined by red lines.
- b. Relief on Opposite Side of Red Penalty Areas:
Red penalty areas with an opposite side relief option will be indicated, **if applicable**, on the “Notice to Players”. Model Local Rule B-2.1.

Note: When the edge of a red penalty area coincides with the boundary of the course, Model Local Rule B-2.2 is in effect and modifies the second paragraph of Model Local Rule B-2.1.

3. Abnormal Course Conditions – Rule 16.1

- a. a. Defined by areas completely encircled with white lines.
- b. b. French drains filled with stones.
- c. c. Seams of cut turf. [DB1] Model Local Rule F-7 is in effect. Lie of ball and area of intended swing, not stance.
- d. d. Bunker Liners. An exposed liner is treated as ground under repair by the Committee under Rule 16.1. But interference does not exist if the liner only interferes with the player’s stance.

4. Immovable Obstructions – Rule 16

- a. White lined areas tying into obstructions are deemed to have the same status as the obstruction and are not ground under repair.
- b. Landscaped garden areas completely encircled by an obstruction are part of the obstruction.
- c. Mats secured to the ground and rubber or plastic bumpers covering cables.
- d. When railroad ties, curbing or the like adjoin artificially surfaced roads or paths, they are deemed to be part of the road or path.
- e. Bird houses

5. Integral Objects

Include cables, rods, wires or wrappings when closely attached

to trees, artificial walls and pilings when located in penalty areas or adjacent to bunkers.

6. Wood Chips and Mulch — Are loose impediments.

7. Elevated Power Lines, Poles, Towers or Cables - Model Local Rule E-11 is in effect and is modified as follows: If it is known or virtually certain that a player’s ball hit a power line in bounds, the stroke does not count and must be replayed under Rule 14.6

8. Temporary Immovable Obstructions – (TIOs).

Model Local Rule F-23 is in effect.

- a) Either side relief is available as an extra option for the Line of Sight Interference for TIOs listed on the applicable “Notice to Players”. Note: This option does NOT apply to a player taking physical interference relief under 16.1.

9. Specifications of Clubs and the Ball

- a. Replacing Club that is Broken or Significantly Damaged – Model Local Rule G-9 is in effect.
- b. List of Conforming Driver Heads – Model Local Rule G-1 is in effect. Penalty for making a stroke with club in breach of this Local Rule – Disqualification.
- c. List of Conforming Golf Balls – Model Local Rule G-3 is in effect. Penalty for making a stroke with a ball in breach of this Local Rule – Disqualification.
- d. One Ball Rule is not in effect unless noted on the Notice to Players- Model Local Rule G-4.

10. Prohibiting the Use of Certain Types of Shoes

- a. Model Local Rule G-7 is in effect.

11. Pace of Play (Rule 5.6b(3)) See posted GPGA Junior Tour Pace of Play Guidelines and for pace of play penalties.

12. Suspension of Play Due to a Dangerous Situation Rule 5-7b

All practice areas are closed during the suspension for a dangerous situation until the Rules Committee has declared them open for use. Players who disregard such closing will be subject to disciplinary action by the Section Tournament Committee.

NOTE: A suspension and resumption of play will be signaled by:

- a. Discontinue Play Immediately: One Prolonged Signal Note
- b. Discontinue Play: Three Consecutive short notes
- c. Resume Play: Two short signal notes

13. Practice

- a. Before or between rounds in stroke play - Model Local Rule I-1.1 is in effect and Rule 5.2b is modified as follows: A

player must not practice on the competition course, but may practice on the designated practice areas. Penalty for breach of Local Rule, see Rule 5.2.

b. Between holes in stroke play - Model Local Rule I-1.2 is in effect and Rule 5.5b is modified as follows:

Between the play of two holes, a player must not:

- i. Make any practice stroke on or near the putting green of the hole just completed, or
- ii. Test the surface of that putting green by rubbing the putting green or rolling a ball.

14. How to Decide Ties

In the event of a tie for the tournament in the Overall Boys & Girls Divisions, a hole-by-hole playoff will take place following all scores being approved by the Committee. If the course is not readily available, the winner will be decided by matching scorecards based on the best score for the last round. If there is still a tie, the winner will be determined in this order: the last nine holes, last six holes, last three holes and finally the 18th hole. If there is still a tie, the winner will be determined by lot.

NOTE: If there is a double tee start, then holes 10-18 will be used.

15 Scoring Area and Returning Scorecard

- a. The scoring area may include, but is not limited to tents or rooms and may be designated by ropes/stakes and/or the blue lines/dots, or the like.
- b. For the purpose of applying Rule 3.3b(2), A player's/team's scorecard is deemed to have been returned when the player has relinquished possession of the scorecard to the Committee and has exited the immediate scoring area with both feet. Prior to returning the scorecard, a player that needs to leave the scoring area must inform the Committee of his/her intention to leave and immediately return.

16. Close of Competition

The competition shall be deemed to have closed when all scores have been posted on the official scoreboard and approved by the Rules Committee. In the event of a playoff, the competition shall be deemed to have closed when the playoff scores have been approved by the Rules Committee.

- 17. Cell/Smart Phone and other electronic devices (ED):** EDs shall be turned off or to a silent condition during the players stipulated round. Conversational use shall be limited to emergency use only or to call for a ruling.

EDs may be used for live scoring or to check the on-line leader board of the event being played.

Text or email function may only be used for critical or very important issues providing there is no audible sound and the use does not distract other players.

Any player deemed by a tournament official to be distracting play will be asked to discontinue all use of their EDs for the remainder of the stipulated round. If a player continues to use their EDs they will be withdrawn from the event immediately.

Any player delaying play due to non-emergency use of a ED will be subject to penalty under Rule 5.6b.

GPGA JUNIOR TOUR PACE OF PLAY GUIDELINES

DEFINITION OF OUT OF POSITION: The first group to start will be considered out of position if, at any time during the round, they exceed the time allotted to play, as detailed on the applicable Pace of Play Time Chart.

Any subsequent groups will be considered out of position if, at any time during the round, they (a) exceed the allotted time to play and (b) reach a par-3 hole that is open and free of play or reach a par-4 or par-5 and have not played a stroke from the teeing ground before the hole is open and free to play. Both (a) and (b) must apply for a group to be out of position.

NOTE: The Rules Committee reserves the right to time a group/individual when the Rules Committee deems it necessary. Further, if a player is determined by the Rules Committee to be unreasonably slow he may be timed individually at the Rules Committee's discretion, **regardless** of whether his group is out of position or over time par. If a group is out of position but not over time par the Committee reserves the right to ask the group to get back into position with the group(s) in front of them.

TIMING: When the Rules Committee determines that a group or an individual will be timed, all players in the group, or the specific individual, will be informed they are being timed. A group or an individual will be informed after leaving the teeing ground and before any further strokes. Timing will discontinue when the group has regained its position. Any timing exceeding the allotted time to play will be carried over for the remainder of the round.

Other than on the putting green, the timing of a player's stroke will begin when it is his turn to play and he can play without interference or distraction. Time spent determining yardage will count as time taken for the next stroke.

On the putting green, timing will begin after the player has been allowed a reasonable amount of time to mark, lift, clean and replace his ball, repair his ball mark and other ball marks on his line of putt and remove loose impediments on his line of putt. Time spent looking at the line from beyond the hole and/or behind the ball will count as time taken for that stroke.

NOTE: A player is permitted 45 seconds to play a stroke, and an extra 15 seconds (for a total of 60 seconds) will be allowed for: (a) the first player to play a stroke on a par-3; (b) the first player to play a second stroke on a par-4 or par-5; (c) the first player to play a third stroke on a par-5; (d) the first player to play around the putting green; and (e) the first player to play on the putting green.

PENALTIES: Any player in a group being timed, who exceeds the applicable time to play a stroke, will be informed as soon as practicable and is subject to the following penalties:

FIRST OFFENSE: Warning SECOND OFFENSE: One (1) Stroke Penalty
THIRD OFFENSE: Two (2) Stroke Penalty FOURTH OFFENSE: Disqualification

NOTE: IF YOU WISH TO KNOW YOUR POSITION, PLEASE ASK A GEORGIA PGA OFFICIAL.

GEORGIA PGA RULES COMMITTEE
